- All presentations will run from the moderator's PC/Windows-based computer.
- Presentation decks should be converted to Powerpoint format .PPX (97-2003 or later versions).
- Videos should be HD quality of 720p or better, using any of the following formats, .mov, .mpg, .mp4, .avi, .wmv.
- Video clips **MUST** be sent as a separate file from the presentation deck.
- Each video clip should be labeled with the product name and corresponding slide, (e.g. Product\_Slide3).

- NO DISTRIBUTION OF SAMPLE PRODUCTS OR PRODUCT LITERATURE
